HEALTH REGULATIONS

*All Upland Game Birds, Poultry and Waterfowl (all types of Ducks, Geese and Swans) should be pullorum tested winged or banded currently or within the last 30 days. All out of state birds should be tested prior to sale and have general health papers. You must have test papers with you, no test papers in hand your birds will be tested. Chicks and hatching eggs must come from a NPIP Flock

Test papers must be filled out completely. Poultry tested for sale must be identified with a leg or wing band.
Questions call 320-231-5170 State Board of Animal Health

NOTE: For a certified tester in your area call the State Board of Animal Health 320-231-5170. However, a certified tester will be available on Sale Day. **ALL** birds or waterfowls not tested prior to sale **MUST BE IN A LATCHED CAGE-EASY TO OPEN.**

*All Turkeys must be tested prior to auction for S. Typhumurium and Mycolplasmas (Mycoplasma Gallisepticum and Myscoplasma Synovia) **Must have test papers for turkeys in hand or they can NOT be consigned. Turkeys must be tested no later than 2 weeks prior to sale.**

***Ratites**-There is no test requirements at the present time.

*All types of **Deer and Antelope, Elk, Moose and Caribou** effective 01/04 must be registered in the CDW program (chronic wasting disease). For more information call 651-296-2942 ext. 4. Any deer brought in without being registered in this program will NOT be accepted.

***Cattle**-General Health Papers

***Buffalo**-Negative T.B. Bangs test within 30 days of Sale

***Equine**- Negative Coggins test required on all horses, mules and donkeys. Horses, donkeys, mules, and llamas must have a halter or you will be charged \$7 for a halter.

***Goats & Sheep** -No test Needed. Goats going out of state need TB test. If animal do not have Scrapie tags one will be provided for a fee.

USDA Scrapie Eradication Program-all animals any age are required to have an official USDA ID tag before shipment. Call 866-873-2824 for free tags and tagger.
